

Protocol .151-B Family and Children’s Health Services Fees FY-2013

FEE IMPLEMENTATION GUIDANCE— TITLE X FAMILY PLANNING AND DISTRICT CARE SERVICES:

Title X Family Planning

- Title X Family Planning services are provided only to clients who are of child bearing medical status and age and who are seeking a contraceptive method.
- Title X Family Planning program services include reproductive health exams plus dispensing of contraceptive supplies.
- Title X Family Planning fees are assessed based upon a sliding fee scale according to client income and family unit size. Title X Family Planning clients self-report income, and verification is not required (See Protocol .151-A Income Guidelines for Family and Children’s Health Services Fee Schedule.)

District Care

- District Care clinical services include only non-Title X Family Planning services.
- District Care services include but may not be limited to STD/HIV screening, counseling, and treatment services; communicable disease screening services for TB and refugee program clients; and other Family and Children’s Health services.
- District Care fees are based upon the same fee schedule as for Title X Family Planning services with the following additional conditions:
 - Any reduction from the maximum fee requires formal income verification.
 - The reduced fee will be no lower than 40% of the maximum fee for the service. (See Protocol .151-A Income Guidelines for Family and Children’s Health Services Fee Schedule.)
